The Big Business of Aiding & Abetting War Crimes and Genocide

According to research conducted by *Just Peace Advocates* (go to justpeaceadvocates.ca):

-Investments in companies implicated in illegal activities in the Occupied Palestinian Territories (oPt) violates the International Court of Justice (ICJ) Advisory Opinion, the Geneva Conventions, which are indictable under the Criminal Code of Canada (CCC) Section 21 and the UN's terms and principles of responsible investment (PRIs).

-According to the 2024 ICJ Advisory Opinion, Canada must eliminate economic and financial relations with Israel.

-Canada is responsible for due diligence to examine private enterprises such as banks in order to ensure they are "not engaging in any business, activity or financial support that maintains the unlawful occupation or contributes to maintaining it."

A few examples of military sector investments - all of which constitutes active support for Israel's occupation and genocide.

-**Elbit Systems** - Israel's largest weapons producer, which makes drones, combat vehicles, munitions and more.

-**Caterpillar**- provides Israel with the D9 to raze Palestinian homes and destroy agriculture.

-**CAE Inc.** - provide the Israeli military with trainers and aircraft simulators.

-**Alphabet Inc. (Google)** - involved in Palestinian rights violations through Project Nimbus.

-And many more...
